1. Registration Process and Payment

- b. Online registration is only open until **28th November 2019 (GMT +8hrs)**. After 28th November 2019, kindly register onsite at the Congress venue where registration counters will be open on 3rd December 2019 from 1400 – 1800hrs. Only credit card or cash (in MYR currency) is applicable for onsite registration.
- c. In order to enjoy the Early Bird Rates, full payment of registration fees must be received on or **before 30th September 2019**. However, this does not apply to **PRESENTERS** as they are required to complete their registration with payment by **31st July 2019** in order to confirm their participation and to ensure their abstract(s) are published in Congress programme and proceedings.
- d. For Regular Rates, full payment of registration fees must be received on or before **28th November 2019**.
- e. For Onsite Registration, full payment must be made before collecting your name badge during the Registration Day.
